KERSLAKE RECOMMENDATIONS

The Kerslake Report - an independent review into the Manchester Arena Attack contains over 50 recommendations many of which refer to effective joint working for emergency services and LRF partners. All the Kerslake recommendations have now been inputted onto JOL Online but not yet published. 17 of these are related directly to effective joint working. The Interoperability Board will be monitoring activity against those 17 recommendations to ensure we learn lessons and continually improve our planning, response and recovery arrangements



Learning from previous incidents is vital to improve our response, reports like Kerslake highlight the importance of your organisation using JOL Online.

MINISTERIAL LETTER

On 30th July 2018 a letter was sent from The Rt Hon Ben Wallace, the Minister for Security and Economic Crime and The Rt Hon Nick Hurd, the Minister for Policing and Fire to specify that formal and sustainable local processes for identifying and sharing multi-agency lessons nationally need to be in place. This process includes the use of JOL Online for Emergency Services and LRF partners. Responder agencies should ensure they have robust procedures in place to input any lessons identified and/or notable practice onto JOL Online.

JESIP Guide to creating a JOL Memorandum of Understanding

You should all have received notification of the JESIP Guide to creating a JOL MoU. We encourage the local adoption of this MoU with your partner organisations in order to assist in achieving Recommendation Six from the JESIP Assurance Programme Report on Findings November 2017 which states '*Lessons identification and sharing arrangements should be formalised through the development of local policies that support the identification of lessons through appropriate multi-agency debrief processes and sharing them via JOL Online*'.

LESSON IDENTIFIED

When attending an incident where the IOR process is in use, responder agencies should adopt the JESIP principles to ensure the effective use of joint working.

LESSON IDENTIFIED

LI01314

In some remote areas, communications via the use of airwave or mobile phones can suffer. It has been identified that contacting your organisation's communications advisor (or airwave Tactical Advisor) at an early stage can be beneficial to assist with communications issues.

NOTABLE PRACTICE

The safety of emergency responders is paramount and to underpin this, there has been an agreement across Fire, Police and Ambulance services to deliver an awareness package on fire behaviour to all frontline police and ambulance staff.

LESSON IDENTIFIED

Multiple lessons are still indicating that the use of interoperability talk groups are not being requested at a wide range of incidents. When commanders are unable to co-locate face to face due to the nature of the event, an interoperability talkgroup should be established. This will help to ensure that all responder agencies have a joint understanding of risk and shared situational awareness.

Do you know what the Work-related Deaths Protocol (WRDP) is? Do you if know your agency is a signatory? The WRDP sets out the principles for effective liaison during criminal investigations of work-related deaths in England and Wales. For further information go to:

When creating an exercise or local training event, consideration should be given to relevant local voluntary agencies that may be called upon during a live incident. This enables a common understanding of capabilities and reduces response times on scene when processes are already in place.
